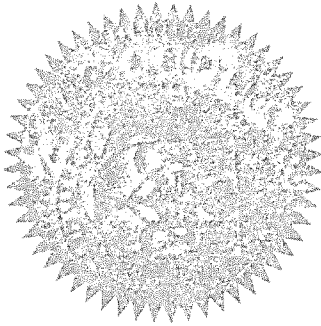

**INTERIM ORDER**

**THIS MOTION**, made by the Applicant for an interlocutory Order in the within Application requiring the Respondent, The Corporation of the Town of Oakville (incorrectly named as The Town of Oakville) (the "**Town**") to produce all relevant records of the municipal election of October 22, 2018 in respect of Wards 6 and 7 of the Town, and that the Town retain and not destroy any ballots or other documents and materials relating to the election until such time as this Application and any potential appeal therefrom has been finally disposed of, was heard this day at 491 Steeles Avenue East, Milton, Ontario.


**ON READING** the Notice of Application and the Consent of the parties, filed, and on hearing the submissions of counsel for the Applicant and for the Town,

1. **THIS COURT ORDERS** that the Town shall produce to the Applicant all documents requested at paragraphs 1(a)(ii) to 1(a)(ix) inclusive and paragraph 1(a)(xiv) of the Notice of Application.

2. **THIS COURT FURTHER ORDERS** that pursuant to subsection 88(3) of the *Municipal Elections Act, 1996*, S.O. 1996, c. 32, Sched., the Town Clerk shall retain and not destroy the ballots for Wards 6 and 7 in the municipal election of October 22, 2018 until the final disposition of this Application.

3. ~~**THIS COURT FURTHER ORDERS** that this Application shall be adjourned to a special hearing date to be set by the Trial Coordinator.~~

4. *Counsel will write to the Regional Senior Justice for Central West, Justice P. Daly in Brampton, to request a fixed date.*
